Preamble

IN exercise of the powers conferred by subsection 49(1) of the Environmental Quality Act 1974 [Act 127], the Director General makes the following order:

Order 1. Citation and commencement

(1) This order may be cited as the **Environmental Quality (Delegation of Powers) (Investigation of Open Burning) Order 2000**.

(2) This Order comes into operation on 21 August 2000.

Order 2. Delegation of powers.

The Director General delegates the powers under sections 38 (except power to stop, board and search any vehicle, ship or aircraft) and 38A of the Act to the officers specified in the Schedule for the purpose of investigating the offence under section 29A of the Act.

SCHEDULE

(a) Any Superintendent, Probationary Superintendent, Senior Assistant Superintendent, Assistant Probationary Superintendent, Fire Officer Grade I, Fire Officer Grade II and Fire Officer Grade III of the Fire And Rescue Department.

(b) Any police officer in charge of any police station.

(c) Any Medical Officer, State Health Director, State Public Health Deputy Director, District Health Officer, Public Health Engineer and Health Inspector of the Ministry of Health.

(d) Any Health Officer, Environment Officer, Enforcement Officer, Health Inspector, Assistant Enforcement Officer, Assistant Public Health Officer, Cleansing Supervisor, City Officer, Town Officer and Assistant Enforcer of any Town Council, City Council or District Council.

(e) The Director, Deputy Director, Medical and Health Officer, Environment Officer, Senior Health Inspector and Health Inspector of the Health Department of Dewan Bandaraya Kuala Lumpur.

(f) The Director, Deputy Director, Assistant Director and City Cleansing Superintendent of the City Cleansing Control Department of Dewan Bandaraya Kuala Lumpur.

(g) The Director, Deputy Director, Senior Assistant Director, Assistant Director, Superintendent, Deputy Superintendent, Chief Inspector, Inspector, Assistant Inspector, Sarjan Major and Sarjan of the Enforcement Directorate of Dewan Bandaraya Kuala Lumpur.

(h) The Deputy Director II, Building Surveyor, Engineer, Senior Technician, Technician, Senior Assistant Technician and Assistant Technician of the Building Control Division of Dewan Bandaraya Kuala Lumpur.

(i) The Deputy Secretary I, Town Council Officer, Assistant Enforcement Officer and Assistant Enforcer of the Majlis Perbandaran Labuan.
