Preamble

IN exercise of the powers conferred by subsection (1) of section 49 of the Environmental Quality Act 1974 [Act 127], the Director General of Environmental Quality makes the following order:

Order 1. Citation

This order may be cited as the **Environmental Quality (Delegation of Powers on Marine Pollution Control) Order 1993.**

Order 2. Delegation of powers to investigate certain offences.

The Director General of Environmental Quality hereby delegates his powers to investigate offences under sections 27 and 29 of the Environmental Quality Act 1974 to the following public officers:

(a) any port officer and deputy port officer appointed under the Merchant Shipping Ordinance 1952 [70/1952];

(b) any port officer, ship surveyor and inspector appointed under the Merchant Shipping Ordinance (Sarawak) 1960 [Sarawak 2/1960];

(c) any port officer appointed under the Merchant Shipping Ordinance (Sabah) 1960 [Sabah 11/1960];

(d) any fisheries officer appointed under the Fisheries Act 1985 [Act 317];

(e) any officer commanding a vessel or commissioned officer of the Royal Malaysian Navy; and

(f) any officer of customs commanding a vessel or appointed officer of the Customs and Excise Department.

Order 3. Revocation.

The Environmental Quality (Delegation of Powers) Order 1976 [*P. U. (A) 51/76*] is hereby revoked.
