## **Preamble.**

IN exercise of the powers conferred by subsection 49 (1) of the Environmental Quality Act 1974 [Act 127], the Director General of Environmental Quality makes the following order:

### **Order 1. Citation.**

This order may be cited as the **Environmental Quality (Delegation of Powers) Perbadanan Putrajaya Order 2002.**

### **Order 2. Delegation of powers.**

The Director General delegates the powers to officers holding the office specified in column (2) of the First Schedule for the purpose of investigating the offence under the provisions specified in column (1).

### **Order 3. Delegation of powers.**

The Director General delegates the powers to officers holding the office specified in column (2) of the Second Schedule for the purpose of enforcing the provisions specified in column (1).
