PEMANSUHAN BIDANG RUJUKAN (*TERM OF REFERENCE, TOR*) JADUAL PERTAMA DI BAWAH PERINTAH KUALITI ALAM SEKELILING (AKTIVITI YANG DITETAPKAN) (PENILAIAN KESAN KEPADALAM SEKELILING) 2015

Tuan/Puan,

Sebagai langkah dalam menambahbaik dan mempermaksaan prosedur penilaian Laporan EIA, dimaklumkan bahawa penyediaan dan pengemukaan Bidang Rujukan (*Term of Reference, TOR*) bagi aktiviti yang tertakluk di bawah Jadual Pertama, Perintah Kualiti Alam Sekeliling (Aktiviti Yang Ditetapkan) (Penilaian Kesan Kepada Alam Sekeliling) 2015 adalah **dimansuhkan**.

Pemansuhan ini akan berkuatkuasa pada **1 Januari 2021** dan kandungan di dalam *Environmental Impact Assessment Guideline in Malaysia (EGIM)* di bawah perkara 4.2.1 *Term of Reference for Activities Falling Under the First Schedule* adalah dibatalkan.

REVOCATION OF TERM OF REFERENCE (TOR) UNDER FIRST SCHEDULE, ENVIRONMENTAL QUALITY (PRESCRIBED ACTIVITIES) (ENVIRONMENTAL IMPACT ASSESSMENT) ORDER 2015

Sir/Madam,

In lined with JAS initiative to further improve and streamline the EIA Report evaluation procedure, kindly be informed that the preparation and submission of Terms of Reference (TOR) for activities subject to the First Schedule, Environmental Quality (Prescribed Activities) (Environmental Impact Assessment) Order 2015 **has been repealed**.

This revocation will take **effect on 1st January 2021** and the content in the Environmental Impact Assessment Guideline in Malaysia (EGIM) under item 4.2.1 Term of Reference for Activities Falling Under the First Schedule is **revoked**.

This also applies if the Director General of Environmental Quality determines that the implementation of the First Schedule EIA processing is carried out in accordance with the Second Schedule procedure.

Also be informed that for this transition period, there are some cases referred as in **Appendix 1** will still continue as per the existing procedure.

First Schedule TOR which needs to be updated, has not been submitted and has not been validated after 1 January 2021. <i>(Refers to TOR updates submitted after 1 January 2021)</i>	There is no need to submit revised TOR. The EIA report can be submitted considering the comments raised by the Department, agencies and stakeholders during the TOR evaluation stage.
