PELAKSANAAN AUDIT ALAM SEKELILING SECARA DALAM TALIAN DALAM TEMPOH PELAN PEMULIHAN NEGARA

Tuan/Puan,

Seksyen 33A Akta Kualiti Alam Sekeliling 1974 memperuntukan bahawa Ketua Pengarah boleh menghendaki pemunya atau penduduk mana-mana kenderaan, kapal atau premis untuk menjalankan audit alam sekeliling.

2. Semasa pelaksanaan Perintah Kawalan Pergerakan (PKP) oleh Kerajaan, audit alam sekeliling boleh dilaksanakan secara maya dengan skop audit pematuhan seperti kehendak syarat-syarat kelulusan Laporan EIA tertakluk kepada Pelan Pemulihan Negara (PPN).
3. Permohonan pelaksanaan audit alam sekeliling secara dalam maya hendaklah dikemukakan kepada Jabatan Alam Sekitar (JAS) Negeri yang berkaitan. Pelaksanaan audit hendaklah mengikut prosedur yang ditetapkan dalam *Environmental Audit Guidance Manual 2011* yang diterbitkan oleh Jabatan ini.

**IMPLEMENTATION OF ENVIRONMENTAL AUDIT DURING THE
NATIONAL RECOVERY PLAN (NRP)**

Sir/Madam,

Section 33A of the Environmental Quality Act 1974 stated that Director General of Environment may require the owner or occupier of any vehicles, ship or premises to carry out an environmental audit.

2. *During the Movement Control Order (MCO), premises are allowed to carry out an environmental auditing via online with the scope of compliance audit as required in the EIA Report approval conditions. All environmental audit activities are subjected to the National Recovery Plan (NRP).*
3. *Application for the implementation of environmental audit via online must be submitted to the Department of Environment (DOE), state office. The implementation of the audit shall be performed in accordance with the Environmental Audit Guidance Manual 2011 issued by this Department of Environment Malaysia.*
